

CONTEST RULES AND REGULATIONS

2022 Developing Northern Australia Conference Flights & Accommodation Giveaway

- 1. Contest opens at 08.00am AEST 14 June 2022 and closes at 12:30pm AEST 26 June 2022.
- 2. To enter and be eligible to win, entrants must be a legal resident of Australia or New Zealand and be eighteen years of age or older. Employees and their parents, siblings and children, and persons domiciled with an employee of Association for Sustainability in Business Inc, and any other organisation, media, or businesses who assist or aid in the contest are ineligible to enter. Furthermore, entrants must purchase a 3-day in-person standard registration to the 2022 Developing Northern Australia Conference on 6-8 July 2022 in Mackay.

The prize is awarded as: One (1) two-nights stay at The Quest Mackay (Studio Apartment) for the nights of the 6th and the 7th of July 2022 and return flights to Mackay from any capital Australian city. Prize must be accepted as awarded. No substitutions and/or variations of the prize is permitted, except if flights and accommodation have already been booked by the time of the draw, winner will be reimbursed. Limits to accommodation are AU\$500 for the two nights. Flights must be economy-class for reimbursement to be issued, or a reimbursement value of AU\$300 if winner has already booked flights other than economy class.
